FOG SIGNAL BUILDING RESTORATION

Status Report as of July 24, 2017

A meeting was held on July 5 at the office of Shoreline Engineering to address all open issues and discuss the tasks remaining to be completed. In attendance were Ryan Cooper, BLM; Bruce Elster, Shoreline Engineering; Dan Murphy, Wellsona; and Harry Thorpe, PBLSA.

Dan Murphy presented a new approach to fix the cracks above the doorway. Dan proposed replacing the wooden window with a stainless steel window that would act as a truss to support the area above the doorway. Dan also suggested that, instead of the cross stitching, he would use reinforcement rods coming out of the arch.

Bruce felt that Dan's solution was a good one and would offer more long term stability. The approach was approved with the stipulation that the steel window would be color treated to look like the old windows. Bruce agreed to redo the design plan to incorporate Dan's proposed approach. He also cautioned that his ongoing demands could delay the completion of the plans.

Dan stated that he has a 6-week commitment in the October timeframe with the BLM. That commitment will cause the FSB project to pause during that period. All agreed that that schedule could be accommodated.

Final plans, proposals and cost estimates are now ready to be completed. Board approval and official awarding of the contract should follow quickly.

Summary of tower top project – Jim Harris 8/26/17

Bruce Elster continues to enter the design for the stabilization into the computer model. As a priority, he is concentrating on the response for the Fog Signal Building so its construction can begin. I met with him on Monday 7/24/17, and we reviewed the co-op proposal schedule for the tower restoration. While the schedule is ambitious, Bruce stated that the three-phase sequence is reasonable. The schedule reviewed is presented below:
