David Cooper called the meeting to order at 6:00 pm.

Announcements- *M/S/P* to approve agenda with amendment to move FSB to #1 position.

Approval of the agenda- M/S/P minutes from January 25, 2017, approved.

Reports:

- 1. FSB Report- Harry gave overview of FSB: 4 phases of work. Dan Murphy gave presentation. He presented for board review and approval a Wellsona Iron and Engineering bid for the structural stabilization of the FSB as designed by Shoreline Engineering. He had 3 masonry contractors look at the building- no one would give a hard price for work. The biggest cost is archway repair because it's a structural repair. Re: lead paint possibility- BLM will offer declaration of nonhazardous material. Re: painting- board consensus is to leave it unpainted as it is now. BLM will have final say. A future issue will be the flooring, but isn't part of the proposal. Board has consensus in opinions and review in construction techniques and cost and intends to call for a resolution before next board meeting under proviso of hazardous materials (lead based paint) and whether to paint or not. Attachment 3: Tower Update 2/22/17 – Jim Harris

Summary of tower top project 2/22/17

Bruce Elster has been supporting Dan Murphy and his preparation of the proposal for the completion of the Fog Signal Building, in particular answering questions on the engineering requirements for the construction, and the development of a "two jack system" to repair severe cracks in the brickwork. He also has been focusing on some additional work for the initiation of the restoration of the Pismo Beach Pier that was not anticipated. He continues to pursue the design effort for the construction of the interior structure for the stabilization of the tower. With the other work winding down, Bruce will focus his efforts for the next month on the tower stabilization analysis and design.

For the past 25 years, PG&E has led various initiatives to help conserve bird species. We're working collaboratively with organizations such as the U.S. Fish and Wildlife Service to minimize the dangers that transmission lines and other electrical equipment pose to birds. In 2008, PG&E won Audubon California's first-ever Corporate Achievement Award for significant achievements in protecting California birds and important habitat.

Dear Mike:

I am a board member with the Piedras Blancas Light Station Association. Last year, you and I had a brief phone conversation about the removal of the power poles from Hwy 1 to Piedras Blancas Light Station (about 2,000 feet and nine poles). A few years ago, our Board President Jim Harris had started talking with PG&E about removing the power poles. I am picking up where he left off and hope to gain some knowledge about the removal process and create an environment that protects our raptors.

One of the goals at the Light Station is to be good stewards of the site and to protect the wildlife, native plants and historical architecture of the 142-year-old facility. All of the volunteers, BLM employees and visitors love the diversity of the ecosystem within the 20-acres that has just been included in the California Coastal National Monument. Observing the pair of Peregrine Falcons that nest high on the Outer Islet from the nature trail is exciting and a highlight of our public tours. Falcons perch on the top

of the lighthouse and are seen hunting over the light station and in flight between Hwy 1 and the shoreline.

Last year we lost one of the three falcon chicks after they fledged from the nest; it flew directly into one of the power poles just short of the lighthouse. It became trapped between the wire and the pole (see attached photo). Unfortunately, birds hitting power poles is not an unusual occurrence at Piedras Blancas.

PG&E has taken steps to prevent bird strikes between Hwy 1 and the light station by installing reflector cards on critical areas. This has been effective at diverting the pelicans and gulls around the point of the Light Station and not over the power lines. However, falcons are not as predictable as pelicans as they fly much faster and are often chasing prey. The power poles and lines pose a real danger (see attached photos).


With the release of California Condors within 10 miles of the Light Station, and knowing that they may start venturing farther away from their release site, soon they could use the Light Station to forage for food along the shoreline. We hope to remove any possible threats for all birds, but especially endangered species like the condor.

We have noticed that the Avian Protection Plan has moved power poles in Big Sur, and PG&E is planning to remove poles near the old Piedras Blancas Motel 1.5 miles north of the light station. With the current work being done in the area, would it be efficient and advantageous logistically to remove our nine power poles and re-route our power service now? Would this be within the scope of your current Avian Protection Program?

Any advice on this issue is welcomed and appreciated.

Whereas, Donovan Marley devoted countless hours for over two years in a successful effort to conserve forever a spectacular and fragile segment of coastal land known for its unparalleled beauty,

NOW THEREFORE, BE IT RESOLVED, that the Piedras Blancas Light Station Association Board of Directors does hereby unanimously recognize, commend, and thank Donovan Marley for his leadership, dedication, and commitment to public land stewardship.
