Appendix 5: Tower Update

Summary of tower top project 4/27/16 Jim Harris

Bruce Elster of Shoreline Engineering has not received any comments on the final documentation from the phase 1 tower study from the BLM engineers in Denver. He continues to work on his design for stabilizing the tower in preparation for submitting a proposal for the next phase of the tower study. The design for the tendon placement has matured to three different sets of rods, and he wishes to contact the BLM engineers (Barry Weldon, I believe) and Joe Jakubic of International Chimney to discuss his idea for placing the tendons before further effort. After getting some confirmation from his colleagues that his design approach is viable, then he can proceed to develop his proposal for the next phase of the study. The remaining work for the study is in two parts: the first is to verify the tower stabilization design with the modified RISA-3D simulation model, and the second is to develop construction drawings for both the stabilization of the tower and for the restoration of the top three levels. He continues to approach the design of the tower stabilization with the constraint that it will support all the options possible for the eventual restored top three levels. The expectation and hope is that Bruce will get the confirmation that he seeks from his colleagues that his tendon design approach is a good one, and then he will have the technical direction that he needs to prepare his proposal for the completion of the tower study. This will allow the board to be able to review a proposal at the May board meeting.

RE: Piedras Blancas California Coastal National Monument (CCNM) Update

On April 5, 2016 the County of San Luis Obispo Board of Supervisors unanimously approved a resolution endorsing the California Coastal National Monument Expansion Act, the jewel in the crown of local endorsements.

I want to brief you on two significant shifts taking place in the campaign to secure national monument status for the Piedras Blancas Outstanding Natural Area. First, under the leadership of the Conservation Lands Foundation, the focus is changing from local initiatives like ours to coordinated attention on a unified front of all five on-shore sites included in the Expansion Act. They include: Cotoni-Coast Dairies (Santa Cruz County), Piedras Blancas (San Luis Obispo County), Trinidad Head, Lost Coast Headlands, and Lighthouse Ranch (Humboldt County). Second, the campaign is shifting gears from the legislative process to executive branch proclamation under the authority of the Antiquities Act. The goal is to secure President Obama's proclamation by mid 2016.

I am requesting informal consent from the PBLSA Board to include a home page link on our website to the new website organized by the Conservation Lands Foundation (YourCaliforniaCoast.org) that focuses on the unified five site strategy. As local co-sponsor of the Piedras Blancas National Monument Initiative, it is important that we cooperate in this statewide effort to present various expansion campaigns as a unified movement. I also want to encourage *The Beacon* editors to include a front-page story about the important role the PBLSA has played in the campaign for national monument status. We are succeeding, and we need to let association members know about it.
