Attachment 4 Summary of tower top project 5/26/21 – Jim Harris

Bruce Elster continues to focus on the development of his computer model of the tower restoration design, and the plan remains that a document for the preliminary design work and cost estimate is to be completed in June/July timeframe. A meeting was held at Shoreline Engineering in Morro Bay on Friday May 4 with Bruce, Ryan Cooper, David Cooper, Dan Murphy and Jim Harris; the agenda was the status and plans for the tower restoration document, its review by BLM engineering in the Denver office, and proposed external design review based upon the documentation (with expectation that Architectural Resources Group in San Francisco will be involved with this review). The project has been proposed as one of the two projects in California forwarded to the BLM Great American Outdoors Act program for funding in the 2021 fiscal year, and Ryan noted that we should hear something by October 2021. David said that he is in contact with Representative Carbajal's office offering to provide background information to them on this BLM opportunity.

Attachment 5 Summary of underground utilities project 5/26/21 – Jim Harris

The undergrounding of the PG&E electrical supply lines project remains on hold. The plan is for the Board to consider a motion that allows Maxwell Muscarella and Sean Cassidy of Connected Energy along with Brian French to present their work at the July Board meeting on the design of a sustainable option to allow electric power for the light station to be provided with or without grid input using a microgrid system with solar and motor generator input and battery storage.

Attachment 6 Capital Campaign/Grants Report 5/26/21 – Jim Harris (David Cooper)

On Thursday May 20, 2021, Jim Harris met with Jeanette Vierra, Vice Chair, of the Pismo Beach Chamber of Commerce at their office; the contact report is presented below. Based upon this experience, Jim and Harry Thorpe will be meeting on Thursday of this week to discuss the goals for meeting ten other chambers of commerce identified as part of our \$2500 grant from the Conservation Lands Foundation to support the project.

Contact Report with Pismo Beach Chamber of Commerce Jeanette Vierra, Vice Chair May 20, 2021 Thursday 3:00-3:35pm By Jim Harris

I made an appointment with Jeanette Vierra, Vice Chair, of the Pismo Beach Chamber of Commerce to meet at their office in 649 Dolliver St. in Pismo Beach. I presented the bag of material to her from the PBLSA prepared by Holly Gant, and our discussion lasted a little over one-half hour. I first let her read the letter of transmittal from David Cooper (included below for reference), and then we went over each item in the bag including the model of the light station tower. I also mentioned the fourth grade class visitations and some of the special events that the light station has hosted. Emphasis was on the fact that we are in the process of restoring the light station, and our purpose for the meeting was to introduce ourselves and explore areas of mutual interest in the tourism industry. She suggested that we become members of the Pismo Beach Chamber of Commerce in the non-profit category for \$150 per annum. She also agreed to present light station brochures to the weekly farmers market and to the visitor's center on the pier; I said I would look into that suggestion.

We appreciate your willingness to meet with our PBLSA board member Jim Harris and to learn more about the activities at the Piedras Blancas Light Station. It is our pleasure to provide your organization with a model replica of our historic light station tower, a book by Adams and Bogacki presenting the history of the light station, and a brochure describing the status of the restoration of the light station and of future plans.

The light station is located a few miles north of the Hearst Castle and Hearst San Simeon State Park on Highway 1, and is adjacent to the Piedras Blancas Elephant Seals Rookery. The 19 acre site, declared a National Monument in 2017, has been managed by the Bureau of Land Management since 2001. To support the BLM, the Piedras Blancas Light Station Association was created as a 501(c)(3) in 2004 to provide resources to restore and preserve Piedras Blancas Light Station to its period of greatest historical significance, provide educational opportunities to the public, and facilitate scientific research. A Board of Directors leads the PBLSA, and is supported by a Program Associate. More information can be obtained at the PBLSA website <u>piedrasblancas.org</u>.

You are aware that tourism is the biggest sector of the economy in San Luis Obispo County. We believe that natural attractions such as the Piedras Blancas Light Station are a big factor in that recognition. We hope that as you learn more about the light station and its Piedras Blancas Outstanding Natural Area, you will grow to appreciate the value that it gives to the goals of your organization. We hope that the PBLSA and your organization can become good partners in the future growth of tourism within San Luis Obispo County.
